■ I testified the last week in October alongside our member civic associations before the Council on the University Blvd. Corridor plan, zoning changes, ZTA 25-12. My testimony focused on the analysis by the county Racial Equity and So-

cial Justice review that "anticipates ZTA 25-12 could have a negative impact on racial equity and social justice (RESJ) in the County. Given the high rates of homeownership of Black and Latinx community members in the... Plan area, the proposed rezoning that is inherent to ZTA 25-12 could disproportionately displace existing Black and Latinx homeowners for the development of market-rate housing units that primarily benefits White, Asian, and Pacific Islander community members." See links to these on our website.

I also covered the conflict between this plan and the More Housing N.O.W., which has not even taken effect yet, and the anticipated problems with traffic, stormwater management, and a host of other issues that may arise from putting multifamily housing in single-family neighborhoods. The testimony has been posted on our website under the Planning and Land Use Com-

mittee.

Update on the PEPCO Shared Use Recreational Trail

Michael Zelaski from the County's Parks Department reports on the status of the Shared Use Path for which the Civic Federation was a major instigator:

"The contractor was selected for the north trailhead (north of Cabin John Regional Park); construction was slated to begin this October but is now starting to look like November "The south trailhead (south of Cabin John Regional Park) stormwater management is partially being redesigned to reduce impacts to significant trees. To that end, a second site had to be coordinated with the Dept of Permitting Services, surveyed and designed, that effort is on-going.

"The crossing of Cabin John Creek has been designed, along with the associated stream stabilization. This is in the permitting stage." ■





Washington, D.C., Streetcar Service to End March 31, 2026

The District of Columbia street car service is scheduled to end on March 31, 2026. The D.C. Streetcar was launched in March of 2016 as a single line along H Street that runs 2.2 miles between Union Station and the edge of the RFK Stadium Campus. Riders who used the streetcar line are encouraged to plan and explore alternate travel options, including WMATA's D20 bus.

District of Columbia Department of Transportation officials said the decision comes after years of low ridership. They also cited the system's operational challenges because it ran in mixed traffic, and it also racked up higher costs to maintain and extend the system. The system averaged about 1,300 riders in each direction. The system never charged fares because it was not set up to collect fares.

The District Department of Transportation said in February 2018 that there have been problems already with getting spare parts to complete repairs in a timely manner. One manufacturer is out of business and the other is overseas, so the issues are likely to continue.

"Long-term parts availability will likely require reverse engineering parts," DDOT officials wrote to the council's Committee on Transportation and the Environment. The agency said it is exploring a strategy of acquiring vehicles in the future that "considers the feasibility of disposal of the current fleet."

Federal Transit Administration guidelines set a streetcar's typical lifespan at 31 years. Even if the current fleet runs for another five years, it would still have only been in service for seven. The cars arrived a few years before the line opened for passenger service.

They also announced service adjustments prior to closure, effective January 4, 2026: elimination of Sunday service and revised operating hours with 20-minute headways:

- Monday–Friday: 6:00 a.m.– 10:00 p.m.
- Saturday: 8:00 a.m.-10:00 p.m. The Purple Line service in Maryland is scheduled to start in two years. Maybe they will want to use the D.C. streetcars. ■
